RESOLUTION #2001-16

A RESOLUTION AMENDING THE VOLUNTARY RESIDENTIAL SIDEWALK PROGRAM IN THE CITY OF FAYETTE, REMOVING THE DEADLINE DATE OF OCTOBER 31, 2000 AND CONTINUING THE PROGRAM FOR AN UNLIMITED TIME OR UNTIL FUNDS RUN OUT.

WHEREAS, the City Council deems it in the best interest of the City of Fayette, Iowa, to assist all property owners in defraying the cost of placement of sidewalks located upon adjacent public right of way.

NOW, THEREFORE, BE IT RESOLVED that the City of Fayette shall extend and fund a voluntary sidewalk placement program under the following guidelines:

A. The City shall create a fund of \$10,000.00 to be made available to all owners of real estate located within the City limits of the City of Fayette, Iowa.

B. Applications shall be submitted to the City Administrator/Clerk at City Hall on forms provided by the City. Completed applications shall be presented to the majority of the City Street Committee for review and approval.

C. Existing sidewalks and those approved by the City Street Committee shall qualify for program funds.


D. Program funds shall be used solely to defray fifty percent (50%) of the cost of the concrete (4000 mix) necessary for installation of sidewalks. A maximum grant of \$265.00 may be paid per property. Property owners with corner lots shall receive program funds to defray fifty percent (50%) of the cost of concrete for each side of their property. A maximum grant of \$530 may be paid per property if new sidewalk is installed on both sides of the property.

F. Sidewalks qualifying for program funds shall be constructed pursuant to the specifications detailed in Chapter 136 of the 2000 Fayette Code of Ordinances.

G. Applicant shall have ninety (90) days from date of approval to complete work. The City Admin/Clerk may extend this period if circumstances warrant such an extension. Requests for an extension shall be submitted in writing to the City Admin/Clerk explaining the need for the extension.

H. Program funds shall be disbursed directly to the property owner upon completion and: (1) Certification to the City Admin/Clerk the actual cost of the concrete necessary for the replacement of the sidewalk; (2) Proof the supplier of the concrete has been paid in full.
